1 I, George A. Zelcs, declare as follows:

2 1. I am a partner in the law firm of Korein Tillery. I am a member of the Illinois bar
3 and am admitted pro hac vice to practice in this Court.

4 2. I submit this declaration in support of the Consumer Plaintiffs' Statement of At-
5 torneys' Fees and Costs. The facts set forth in this declaration are based on my personal
6 knowledge and on business records associated with this matter and/or my firm. If called as a wit-
7 ness, I could and would testify competently thereto.

8 **THE KOREIN TILLERY TEAM**

9 3. Attached as **Annex 1** is Korein Tillery's firm resume, which includes information
10 about the credentials and experience of the attorneys who led our team for this case. During the
11 pendency of this action, and at the request of and in coordination with Co-Lead Counsel, my firm
12 has worked on behalf of Consumer Class and Consumer Plaintiffs from case inception through
13 settlement.¹ My firm has been involved in multiple activities that were assigned to us by Co-
14 Lead Counsel on behalf of the Consumer Class.

15 **KOREIN TILLERY LEGAL FEES AND COSTS**

16 4. In accordance with instructions from Co-Lead Counsel, all Korein Tillery attor-
17 neys, paralegals, and other billable personnel assigned to this matter made contemporaneous
18 records of the time they devoted to this case, which were maintained in the ordinary course of
19 business in an electronic database administered by our firm.

20 5. Consistent with our standard practice and following instructions from Co-Lead
21 Counsel, I and other attorneys and staff working at my direction audited all of the billable time
22 entries, and deleted any entries in which descriptions were insufficiently detailed, tasks or en-
23 tries appeared duplicative, or if the specific task or amount of time billed was not reasonably
24 necessary to advance the litigation in the interest of consumers. In my professional opinion and

1 judgment, the entries appear to be reliable. In accordance with the Court's order, fee documen-
2 tation was submitted to Co-Lead Counsel on a monthly basis for their review and the final com-
3 piled fee documentation has been provided to Co-Lead Counsel for their additional audit and
4 review.

5 6. Attached as **Annex 2** is a summary of the hours contemporaneously recorded by
6 the billable Korein Tillery personnel who performed significant work in the prosecution of this
7 lawsuit. This summary identifies the total amount of time devoted to each category of tasks by
8 each billable professional using codes that are consistent with those that have been used in re-
9 cent class fee submissions in this Court and other federal courts within the Ninth Circuit. The
10 summary also identifies each professional's name, title, hourly rate, and a calculation of the re-
11 sulting fees. The hourly rates for each attorney and staff member listed are the usual and cus-
12 tomary hourly rates charged by Korein Tillery for similar work. Detailed time entries are also
13 available for inspection by the Court upon request.

14 7. I am personally familiar with the character, quality, and extent of the work per-
15 formed by each of the lawyers and other billable professionals who performed work in this case.
16 In my judgment, the work reflected on the tables attached hereto was necessary to advancing the
17 litigation in the interests of consumers, consistent with the instructions and tasks assigned by
18 Co-Lead Counsel, and performed competently and with efficiency.

19 8. Attached as **Annex 3** is a summary of the costs incurred in prosecuting this law-
20 suit on behalf of Consumer Plaintiffs. The expenses incurred are reflected on the books and rec-
21 ords of Korein Tillery. These books and records are prepared from checks and expense vouchers
22 regularly kept and maintained by the firm and accurately reflect expenses incurred. Cost docu-
23 mentation has also been provided to Co-Lead Counsel for their additional audit and review.

24 9. The compensation to Korein Tillery for the services rendered on behalf of Con-
25 sumer Plaintiffs is wholly contingent. Any fees and reimbursement of expenses will be limited
26 to such amounts as approved by the Court.

Representative Antitrust Cases

In re: Foreign Exchange Benchmark Rates Antitrust Litig., No. 13-cv-07789 (S.D.N.Y.)

Korein Tillery, working with co-counsel, developed and filed a class action on behalf of individuals who entered into global foreign exchange (“FX”) transactions alleging violations of Sections 1 and 3 of the Sherman Antitrust Act and violations of the Commodity Exchange Act. As a result of nearly six years of work by Korein Tillery and its co-counsel, costing the firms nearly \$30 million in case-related expenses, \$2.3 billion in court-approved settlements were reached with 15 of the 16 defendants, constituting one of the largest antitrust class action recoveries in history. Mediator Kenneth Feinberg concluded that this settlement would “represent[] some of the finest lawyering toward a negotiated resolution that I have witnessed in my career” and described Korein Tillery and its co-counsel as “superlative, sophisticated, and determined plaintiffs’ lawyers.”

In re GSE Bonds Antitrust Litig., 19-cv-01704 (S.D.N.Y.)

Korein Tillery, along with co-counsel, alleged antitrust violations arising from coordinated price-fixing in the secondary market for bonds issued by the government-sponsored entities Federal National Mortgage Association, Federal Home Loan Mortgage Corporation, Federal Farm Credit Banks, and Federal Home Loan Banks (“GSE Bonds”). Plaintiffs defeated two

motions to dismiss and reached a settlement with all defendants. The combined settlement provided \$386.5 million to class members and was approved by the court on June 18, 2020.

***In re Google Digital Advertising Antitrust Litig.*, No. 21-md-03010 (S.D.N.Y.)**

Korein Tillery has been appointed interim co-lead counsel representing a class of online publishers that sell ad space on their websites using tools that they purchase from Google. Plaintiffs allege that Google engaged in a series of mutually reinforcing anticompetitive acts in adjoining markets to acquire and maintain monopoly power over the markets for these tools, in violation of the Sherman Act and California's Unfair Competition Law.

***Smart v. National Collegiate Athletic Ass'n*, No. 22-cv-02125 (E.D. Cal.)**

Korein Tillery represents plaintiffs alleging that the NCAA and its member schools engaged in an illegal buyer's-side monopsony by conspiring to fix the compensation of an entire category of college baseball coaches at zero in violation of Sherman Act § 1. Shortly after the lawsuit was filed, the NCAA eliminated the bylaw at issue. The parties have reached a \$49.25 million settlement and a final fairness hearing is scheduled for September 15, 2025.

***In re Crop Protection Products Loyalty Program Antitrust Litig.*, No. 23-md-03062 (M.D.N.C.)**

Korein Tillery was appointed interim co-lead counsel for a putative class of crop protection product purchasers alleging that manufacturers use exclusive "loyalty agreements" with leading distributors to foreclose competition from rival manufacturers and cause purchasers to pay supracompetitive prices for crop protection products.

***Segal v. Amadeus IT Group, S.A.*, No. 24-cv-01783 (N.D. Ill.)**

Korein Tillery was recently appointed interim co-lead counsel for a putative class of purchasers alleging that leading hotel companies used information sharing software to artificially raise the price of luxury hotel rooms in markets across the United States.

***In re Apple iPhone Antitrust Litig.*, No. 24-md-03113 (D.N.J.)**

Korein Tillery was recently appointed interim co-lead counsel for a putative class of Apple Watch purchasers alleging that Apple monopolized the market for iPhone-connected smartwatches.

Korein Tillery Case Team

George Zelcs focuses his practice on complex commercial litigation including antitrust, consumer fraud, securities, qui tam/whistleblower, and pharmaceutical litigation in state and federal courts. Mr. Zelcs has conducted bench and jury trials throughout the United States, including *Price, et al vs. Philip Morris USA, Inc.*, No. 001-0112 (Third Judicial Circuit, Illinois), a consumer fraud class action that resulted in a \$10.1 billion dollar judgment. He frequently serves as lead counsel in complex, multi-party litigations. Mr. Zelcs also played an instrumental role in developing and litigating *In re Foreign Exchange Benchmark Rates Antitrust Litigation*, 13-cv-7789 (S.D.N.Y.), a case that resulted in \$2.3 billion in court-approved settlements. Mr. Zelcs completed his undergraduate degree at Indiana University in 1976 and received his law degree at Chicago-Kent College of Law. He serves on the Chicago-Kent Board of Overseers and as a Trustee for the Chicago-Kent Institute on the Supreme Court of the United States. In addition to serving as co-lead counsel for the publisher class in *In re Google Digital Advertising Antitrust Litigation*, Mr. Zelcs has been appointed co-lead counsel in *In re Motor Fuel Temperatures Sales Practices Litigation*, No. 07-md-1840 (D. Kan.), and *Axiom Investment Advisors LLC v. Barclay Bank Plc*, No. 15-cv-9323 (S.D.N.Y.).

Stephen Tillery has litigated cases throughout the United States involving numerous areas of the law, including securities, antitrust, pharmaceutical, environmental contamination, tobacco, products liability, patent infringement, qui tam/whistleblower, Federal Employers Liability Act, computer technology, and consumer fraud. He has handled, individually or as lead counsel, hundreds of complex civil cases, with more than one hundred resulting in multimillion dollar verdicts or settlements. Mr. Tillery has been appointed lead counsel in more than 40 class action lawsuits. In March 2003, he served as plaintiff's lead trial counsel in a class action trial that resulted in a \$10.1 billion verdict. *Price v. Philip Morris Inc.*, 2003 WL 22597608 (Ill. Cir. Mar 21, 2003), *rev'd*, 848 N.E.2d 1 (Ill. Dec 15, 2005), *reh'g denied*, 846 N.E.2d 597 (Ill. May 5, 2006), *cert denied*, 127 S.Ct. 685 (Nov. 27, 2006). Mr. Tillery was nominated for the Public Justice Trial Lawyer of the Year Award in 2003, 2008 and 2013 for his work in significant complex cases. Mr. Tillery graduated from Illinois College and St. Louis University School of Law. He subsequently served as a law clerk in the United States District Court for the Southern District of Illinois, and the Illinois Fifth District Court of Appeals. Mr. Tillery was an adjunct professor at Saint Louis University School of Law for eleven years, and was Director of the Advanced Trial Advocacy Program there from 1983 to 1988.

Carol O'Keefe is a partner who focuses on complex litigation, including representing antitrust plaintiffs in foreign exchange, commodity futures, and digital economy class actions. Ms. O'Keefe currently plays a leading role in representing digital publisher plaintiffs in *In re Google Digital Advertising Antitrust Litigation*. Ms. O'Keefe works closely with economic and technology experts and taken numerous depositions of software engineers and product managers. Prior to joining Korein Tillery, Ms. O'Keefe was an associate at Harter Secrest & Emery LLP, where she focused on complex litigation, including antitrust, securities, employment discrimination, and civil rights, and worked as an Adjunct Lecturer at the State University of New York at Brockport, where she designed and taught courses in modern constitutional law and education law. Ms. O'Keefe received her B.A. from Yale College *summa cum laude* in 1983 after three years of study, and she received her J.D. from Harvard Law School *cum laude* in 1986. She then served as a law clerk for Judge Michael A. Telesca (W.D.N.Y.).

Marc Wallenstein is a former federal prosecutor and has tried numerous cases to verdict. As an appellate advocate, Mr. Wallenstein is undefeated before the United States Court of Appeals for the Ninth Circuit, having won all ten of the appeals in which he served as lead counsel. Mr. Wallenstein currently leads two parallel class action lawsuits against Google on behalf of users of Android mobile phones in California and nationwide. He recently secured a \$314 million verdict on behalf of the California class of approximately 13 million Android users, *Csupo v. Google*, No. 19-cv-352557 (Cal. Super. Ct.), and won an appeal before the Ninth Circuit on behalf of Android users nationwide, reversing the district court's dismissal of the complaint, *Taylor v. Google*, No. 22-16654 (9th Cir. Feb. 28, 2024). Mr. Wallenstein previously served as trial counsel for thousands of minor league baseball players who won the right to be paid minimum wage by Major League Baseball, achieving a landmark \$185 million settlement on the eve of trial. *Senne v. Office of the Comm'r of Baseball*, No. 14-cv-608-JCS (N.D. Cal.). Before joining Korein Tillery, Mr. Wallenstein served for six years as Assistant U.S. Attorney in the District of Hawaii. Mr. Wallenstein successfully prosecuted the first terrorism case ever brought against an active duty member of the U.S. military and obtained record fines in numerous environmental cases. Prior to his time at the Department of Justice, Mr. Wallenstein served for three years as a Prosecutor at the Office of the Chief Prosecutor of Military Commissions, U.S. Department of Defense. There he prosecuted violations of the law of war committed by enemy alien belligerents before a military commission in Guantanamo Bay, Cuba. Mr. Wallenstein served as an appellate and pretrial motions attorney on a range of cases, including the prosecution of Khalid Shaikh Mohammed and four others accused of perpetrating the attacks of September 11, 2001. Mr. Wallenstein is a graduate of Harvard College and Yale Law School, and previously served as a law clerk in the Southern District of New York and the Ninth Circuit Court of Appeals. In his spare time, he teaches a course in Trial Practice at Yale Law School.

David Walchak is an partner in Korein Tillery's Chicago office.
